Accused Dr.Anuj Kumar Bhattacharjee surrenders by a petition. His surrender is accepted and he is taken into custody and remanded to JC till 23,12,2013. Recall W/A.

A bail petition is filed on behalf of the accused praying for his release on bail. Copy served.

The bail petition is taken up for hearing.

Heard both sides.

Ld Lawyer for the accused submits that because of his eye sight problem he placed prayer for transfer from this place which coincide the date of the incident. He himself was the defacto-complainant, but he is made the accused in this case and C/S filed against him citing him as one of the co-accused in this case. Xerox copy of all the medical papers are filed. He invites attention of the court to xerox copy of the documents filed this day. He went before the Hon'ble Court but could not get relief and ultimately he was asked to surrender before this court and he is now retired from the service.

There is defalcation of the public money from the period w.e.f. 06.02.95 till 26.03.1998. Ld P.P raised serious objection in the matter of grant of bail and contends that the accused must be taken into custody though he himself surrenders today suo motu because of the order of the Hon'ble High Court at Calcutta in CRR-3567/13. Earlier there was stay of the W/A by the Hon'ble Court in CRR-2722/2001 as submitted by this accused Perused the order of the Hon'ble Court.Considered.

Perused the materials on record. This case is very old and other co-accused, persons who were entrusted to day to day affairs of the business and did audit on the transaction of this business, are on bail. Considering the fact and circumstances I am inclined to release the accused on bail though his signature is on the cash register which was maintained by co-accused Ramendranath Sanyal on behalf of the District Leprosy Society. The accused Dr.Anuj Kumar Bhattacharjee thus may find bail of Rs.10,000/- with one surety of like amount in default to J/C till 23.12.2013.If on bail to date i.e. 17.01.2014 for appearance.

Under any circumstances accused has no say as to who will be added as an accused in a criminal case besides them. Accordingly I find the petition filed by the accused is not tenable in law. Hence it is rejected.
