

Accused Dr. Anuj Kumar Bhattacharjee surrenders by a petition. His surrender is accepted and he is taken into custody and remanded to IC till 23.12.2013. Recall W/A.

A bail petition is filed on behalf of the accused praying for his release on bail. Copy served.

The bail petition is taken up for hearing.

Heard both sides.

Ld Lawyer for the accused submits that because of his eye sight problem he placed prayer for transfer from this place which coincide the date of the incident. He himself was the defacto-complainant , but he is made the accused in this case and C/S filed against him citing him as one of the co-accused in this case. Xerox copy of all the medical papers are filed. He invites attention of the court to xerox copy of the documents filed this day. He went before the Hon'ble Court but could not get relief and ultimately he was asked to surrender before this court and he is now retired from the service.

There is defalcation of the public money from the period w.e.f. 06.02.95 till 26.03.1998. Ld P.P raised serious objection in the matter of grant of bail and contends that the accused must be taken into custody though he himself surrenders today suo motu because of the order of the Hon'ble High Court at Calcutta in CRR-3567/13. Earlier there was stay of the W/A by the Hon'ble Court in CRR-2722/2001 as submitted by this accused.Perused the order of the Hon'ble Court.Considered.

Perused the materials on record. This case is very old and other co-accused, persons who were entrusted to day to day affairs of the business and did audit on the transaction of this business, are on bail. Considering the fact and circumstances I am inclined to release the accused on bail though his signature is on the cash register which was maintained by co-accused Ramendranath Sanyal on behalf of the District Leprosy Society. The accused Dr. Anuj Kumar Bhattacharjee thus may find bail of Rs.10,000/- with one surety of like amount in default to J/C till 23.12.2013. If on bail to date i.e. 17.01.2014 for appearance.



If any person is found involved in a criminal case who has not been made an accused in such criminal case then the prosecution can pray for inclusion of that person as accused in such a case before the court. The court being satisfied with the evidence collected by prosecution against such person may make such person as accused in criminal case u/s.319 of the Cr.P.C. In this filed accused has nothing to say.

The court can suo moto direct inclusion of a person as accused in a criminal case u/s.319 Cr.P.C if upon recording evidence of the case it is found that some persons involved in the occurrence are left out as accused. Under any circumstances accused has no say as to who will be added as an accused in a criminal case besides them. Accordingly I find the petition filed by the accused is not tenable in law. Hence it is rejected.

Now let the case record is taken up for consideration of charge against the accused.

Ld. PP in charge opens the case of prosecution by describing the facts of the case and by placing the documents which he wishes to produce in evidence to substantiate a charge u/s.468/409/120-B IPC against the accused.

Today is fixed for hearing petition filed by the accused on 07.02.2020 praying for closure of the case as the prosecution failed to produce all the witnesses in the last schedule those the case is 20 years old and both accused are senior citizen.

The petition is taken up for hearing.

Hd. both sides. Ld. PP in charge submits that he has taken all the steps for examination of all the accused by sending summons to the recorded address of the witnesses but unfortunately six witnesses out of 19 have died and some of the witnesses have left their recorded address due to transfer or retirement from service. He also submits that there was no laches on the part of the prosecution for examination of the accused as per direction of the court. He submits that admittedly the accused persons are senior citizen and the case is 20 years old, so he does not oppose the prayer but he is not willing to request the court to close the case officially.

After going through the case record it appears that there are in total 19 charge sheeted witnesses out of whom only five have been examined and six died. Still eight witnesses are yet to be examined. On last date prosecution was given a direction to sent summons upon CSW-16 & 19 (IO) in the changed address of the witnesses said order was not complied with. Therefore process is yet to be exhausted in this case.

It is of course a matter of concern that huge amount of public money is involved as this case relates to criminal misappropriation of public money by the public servant, so the matter should not be considered so leniently purely on the ground that the accused are senior citizen and the case is 20 years old. Accordingly I am not inclined to allow the prayer of the accused because the prosecution is not going to shoulder the responsibility of closure of the case. Hence prayer is rejected.

It is a old case and there is a direction for disposal of the case within March, 2020. So as far as practicable few short dates be fixed for examination of remaining witnesses.
